While lamenting the number of people in IDPs, Zulum said the development has worsened the plight of the people.

PLSG to partner AfDB on Agro processing zone

The Plateau State Government and the African Development Bank (AfDB) have reached an agreement to establish a Special Agro Processing Zone in the state. This initiative aims to revitalize the state's economy and create employment opportunities for its youth population.

In a statement signed by the Director of Press and Public Affairs to the Executive Governor of Plateau State, Gyang Bere, it disclosed that

the agreement was formalized during a bilateral meeting between Governor Caleb Manasseh Mutfwang and AfDB President, Dr. Akinwumi Adesina, held on the sidelines of the World Food Prize Foundation Dialogue 2023 in Des Moines, Iowa, United States of America.

The discussion arose due to creating an enabling to Plateau State's absence from the initial phases of the AfDB's initiative, which focuses on industrializing agricultural potential in African subnational entities.

Governor Mutfwang highlighted Plateau State's suitability for various agricultural ventures, citing its favorable climatic conditions. He emphasized the potential for improving agricultural products along the value chain, including potatoes, maize, wheat, yam, soybeans, fruits, vegetables, exotic flowers, and various meat productions.

These enhancements, he said, aim to boost Internally Generated Revenue (IGR) and increase farmers' earning capacities.

Governor Mutfwang expressed his commitment environment for investments and ensuring the state's economic growth.

Dr. Adesina on his part, praised the engagement and reaffirmed AfDB's dedication to developing the Special Agro Processing Zone in Plateau.

In addition to establishing the SAPZ, ATDB plans to provide capacity development for Plateau's human resources and integrate the state into other bank programmes, Dr. Adesina underscored the significance of Plateau State's re-enlistment in the SAPZ plan, given its vast untapped agricultural potential.

The SAPZ initiative, with an investment of approximately one billion dollars, is part of AfDB's strategy to boost Africa's

Prematurely commissioned refinery and post-subsidy Nigeria

When former Nigerian President Muhammadu Buhari walked into Dangote's refinery complex that Monday, 22nd May 2023, the world anticipated a new dawn for oil trade in Africa's largest economy. Even though this would be about the fifth refinery on Nigerian soil, it carried the hopes of over 200 million people for three reasons, writes TUNDE AJIA.

FIRSTLY, it is Africa's biggest. It will produce 650,000 barrels per day, potentially addressing Nigeria's decades-long energy supply crisis. In fact, the first product from the refinery was expected to hit the market by the end of July 2023. Secondly, it is not government-owned. Had it not been owned by Africa's richest man, Aliko Dangote, the general public would have dismissed it as another effort in futility, waiting to be frustrated by Nigeria's powerful oil cabals. Thirdly, the existing refineries under government control have been hounded by operational inefficiencies, making them incapable of meeting the growing demand for petroleum products.

Consequently, Nigeria, the oil-rich nation, has imported more than 80% of its refined petroleum products. This makes Nigeria the largest importer of refined petroleum products in Africa, importing primarily from the Netherlands (\$3.62 Billion), Belgium \$1.78 billion), Norway (\$1.2 billion), India (\$992 million) and the United Kingdom (\$760 million). In 2022, Nigeria spent \$23.3 billion on petroleum product imports and consumed an average of 33 million litres of petrol daily. With 650,000 barrels per day, Dangote's refinery plans to export the surplus petrol and turn Nigeria into an export hub for petroleum products. This complex megaproject is said to be the world's largest single-train refinery, costing \$19 billion to build after nearly 10 years of delay and initial estimates of \$12bn to \$14bn. Analysts say the refinery's local production would massively slash the country's import bill.

Relief for businesses as Nigeria waives THE National Bureau of Statistics says prices of prices Rise by 26.76% tax penalties

THE Nigerian government plans to waive tax penalties, outstanding penalties, and interest for companies, in a move that is part of changes to make it easier to conduct business and boost revenues.

Investors often cite Nigeria's many taxes, debatable penalties, and multiple revenue collection agencies as major factors adding to the cost of doing business and discouraging investment.

"We are working on waiving penalties on interest for businesses so that investors can pay the principal amount that is due," Taiwo Oyedele, chair of the Presidential Committee on Fiscal Policy and Tax Reforms, told BusinessDay **Tinubu** on Monday.



THE National Institute for Legislative and Democratic Studies (NILDS) has called for more funding for members of the National Assembly (NASS) for effective monitoring of budget implementation by the executive arm of government.

Director General of NILDS, Prof. Abubakar Sulaiman made the call in Abuja recently while lamenting the difficulties and challenges faced by standing committees in the NASS in carrying out their oversight functions.

Speaking during a visit by the leadership of the Nigeria Union of Journalists (NUJ), FCT Correspondents Chapel, Prof. Sulaiman said proper funding will ensure standing committees of the NASS to carry out their assignments without fear or favour.

"There are issues that border on oversight assignments and I keep saying those issues will not be corrected until we provide more funding for the parliament to do their oversight. And that is what Nigerians will not want to hear.

We have since turned politics into a blood sport where redeyed gladiators ruthlessly eliminate each other for the pleasure of their backers and their (gladiators') selfpreservation.





November polls: Fears mount over insecurity

In two weeks' time, an estimated 5.41 million eligible voters will be heading to polling units to cast their ballots in the governorship elections in Kogi, Imo, and Bayelsa states. Despite assurances by INEC and the security agencies pre-election violence and fear of intimidation threaten success of the November 11 elections, BENJAMIN SAMSON writes.

THE off-season governorship elections in Kogi, Imo, and Bayelsa states on November 11, 2023, will be the first elections to be conducted under the President Bola Tinubu-led administration. However, the recurring problem of politically motivated violence, and attacks on perceived opponents in the states have taken frightening dimensions and are threatening to mar these elections.

In a chat with our reporter, Senior Policy Analyst, Nexter Group, Charles Chimdiya Asiegbu, said its publication titled: "Nigeria's 2023 State Elections: Mirroring Hotspot States," listed Kogi, Bayelsa and Imo states as having a propensity for electoral violence based on historical evidence and the existing security situation.

He said: "With the ongoing campaigns, there is a heightened climate in the state. The environment has generally been characterised by inciting and fierce rhetoric, threats of violence, and actual incidents of violence among key political actors,"

It is worth noting that on July 24, 2023, arsonists burnt down the Social Democratic Party (PDP) campaign office in Lokoja, the capital of Kogi State; this is as it was reported on July 10, 2023, that suspected thugs invaded the SDP campaign office and destroyed billboards, showing the picture of President Bola Tinubu alongside the SDP governorship

Similarly, on June 3, 2023, the Kogi state SDP Governorship Candidate, Muritala Ajaka, escaped assassination by whiskers when his convoy was attacked by gunmen.

A similar attack was reported on Governor Yahaya Bello's convoy allegedly by the supporters of the SDP, leading to some aides of the governor being injured.

The security situation in Kogi has attained mind-boggling proportions.

In Imo state, on September 19, 2023, unidentified gunmen attacked and allegedly killed no fewer than eight security operatives and also set ablaze two vehicles. The security agents affected were soldiers, policemen, and men of the Nigeria Security and Civil Defence Corps (NSCDC).

In another incident on April 21, 2023, gunmen killed five policemen at the Okpala Junction in the Ngor Okpala Local Government Area of Imo state. Also killed during the attack were a couple identified as Mr and Mrs Chinaka Nwagu, who hail from the Amankwo Okpala community.

On July 18, 2022, there was uproar in the state over the killing of 14 youths, who were returning from a wedding in Awo-Omamma in the neighbouring Oru West Council to their community in the Otulu Area of Oru East Local Council of the state, by auspected members of Ebube Agu security operatives, who opened fire on them unprovoked.

Ahead of the governorship election in Bayelsa state, no fewer than three persons were reportedly shot dead in the Nembe Local Government Area of Bayelsa state on February 15, following a clash involving two rival cult groups.

During the 2023 election, INEC moved voting in 141 polling units in Bayelsa State to Sunday; the INEC Chairman, Prof. Mahmood Yakubu, told journalists the move followed interruption of voting process by thugs.

He further disclosed that National Youth Service Corps (NYSC) members handling those polling units were afraid, which led to the postponement. Experts speak

Speaking with our correspondent, a Security Expert, Okechukwu Nwafor, said that despite the fact that there were not many consequences for



electoral violence, politicians deploy all strategies to elections.

He said, "I am not surprised that insecurity is a major concern in the off-cycle elections. People are desperate to win an election. Politicians are ready to kill because to them election is a do-or-die affair. Politicians have seen that there are not many consequences to election violence and thuggery."

He advised that security agencies must be on top of the situation and avoid being partisan or transactional.

He added, "Some security officers have become very partisan and transactional and might turn blind eyes to thuggery.

"I should think by now that the Nigeria Police Force (NPF), which is the lead agency, would have devised strategies for being in this situation. They should start by building a robust synergy with other robust security agencies. The police should be able to deploy enough officers to the three states.


"This new government has a task on their hands to prove to Nigerians that they are on top of the situation and that democracy exists in the country."

In the same vein, another Security Expert, Oladele Fajana, while speaking on the situation noted that, "Insecurity is not new, especially when it comes to election periods. In the past, we have experienced clashes among the party supporters that led to the burning of property and killing in most cases, like that of 1983, which I witnessed," he said

Faiana stressed that, "Proper lanning, responsible policy provision of adequate security, and transparency judgment will help to address the rising insecurity across the country "

He called for synergy between the Police and other security agencies to instill confidence in the minds of voters before, during and after the conduct of the election.

"Security is a critical aspect of the electoral process that requires attention during the entire electoral process and INEC has recently raised an alarm and fears indicating that insecurity may pose a great challenge to the governorship election.



War in Sudan, consequence of a derailed transition

Two hundred days into the war in Sudan, the Sudanese people remain trapped in a conflict not of their own making. More than 9,000 civilians have been killed and 5.6 million forced to flee their homes, while the capital, Khartoum, continues to be ravaged by savage internecine warfare. Meanwhile, the world's attention is gradually shifting elsewhere. Writes Dirdeiry M Ahmed

When the war erupted on April 15, the story circulated by international media outlets was that this is a typical power struggle between two generals who were once allies: Abdel Fattah al-Burhan, the commander-in-chief of the Sudan Armed Forces (SAF), and Mohamed Hamdan Dagalo, also known as Hemedti, the commander of the paramilitary Rapid Support Forces (RSF). Nothing is further from the truth.

Recently, in a statement marking the six months of the war, United Nations Under-Secretary-General Martin Griffiths said this is "one of the worst humanitarian nightmares in recent history". He emphasised the horrific reports of rape and sexual violence and asserted that the country has been engulfed in chaos. Yet, he said nothing as to why the war is being fought.

If the media have mischaracterised the reason behind the eruption of the war, high-level statements from the international community, like the one above, have been completely silent about it. Neither have tried to envision Sudan's path forward.

On April 11, 2019, an uprising triggered by the deteriorating economic situation toppled President Omar al-Bashir, ending his three-decade-long rule. Sudan formerly experienced two uprisings that brought down military regimes in 1964 and 1985.

Given their experience with past uprisings, in 2019, the Sudanese people widely expected a brief political transition that would address economic issues – with the help of the international community and prepare the country for multiparty elections within a year or two. However, that was not to be. This time around, two factors that were nonexistent in 1964 and 1985 came into play and proved to be paramount.

First, because of the "Islamist" comportment of al-Bashir's regime, regional and international players were more focused on "dismantling" it so the elections would not end up bringing Islamists back to power. For this purpose, the international community had to start a project to remake the That was the Framework

Dissolving the former ruling NCP and hunting its leaders outside the beleaguered and fearing purview of the law became the international sanctions for main objective of the transition. A launching a bloody crackdown on a commission that was not sit-in in Khartoum in June 2019 – accountable to the attorney general or subjected to judicial review was formed for this purpose.

The comprehensive overhaul of the country included calls for Sudan to join the Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW), to rush into convening pride parades even before homosexuality is decriminalised, and to normalise relations with Israel by joining the Abraham Accords. These controversial issues the Middle East, North Africa, East were imposed on the schedule of the transition, even though they

are the business of an elected narliament.

Second, uninitiated neoliberals mostly former communists and Baathists - were anointed by the international community as the legitimate heirs of al-Bashir. As soon as they became comfortable in their new positions, they completely forgot about the economic woes of the country and failed to produce any programme for reform. Additionally, they did not want to hold any elections, bearing in mind the narrowness of their support base.

Soon enough, they locked horns for power, each wanting to have a larger piece of the cake in this exceptionally long transition. As a matter of fact, the entire transition was transformed into an exercise in fielding the neoliberals as the newfound political elite of the country.

When the Constitutional Charter of August 2019, which sealed a marriage of convenience between the military component (both SAF and RSF) on one the hand and the neoliberals on the other, frayed in October 2021, the international community pushed another deal down the throat of the two sides. Agreement of December 2022.

Eventually, Hemedti - already threw in his lot with the neoliberals in a bid to improve his political fortunes. Allegedly, he was also on a mission "to restore democracy and civilian rule".

By then, it was clear to diplomats in Khartoum that an eventual showdown between SAF and RSF was inevitable. Yet, nobody was willing to call for ending the faltering transition and convening elections.

Sudan sits at the intersection of Africa, and the Sahel. As such, it is very much in the throes of all ills of these regions. In this accursed quarter, if you profess a position tolerating the possible return of Islamists to power, you are grabbing the third rail with both hands.

That is mainly because some groups and countries in this region are very quick to attack anyone who questions whatever they are doing to exclude Islamists. For them, any Islamist is a member of the Muslim Brotherhood and a likely operative of ISIL (ISIS), al-Shabab or Boko Haram.

In Sudan, in particular, such conversation takes place in the shadow of three decades of government that the West abhorred and always accused of doing something nefarious. This had been the case even though that government went to great lengths to gain Western acceptance, including by agreeing to the secession of South Sudan, adopting the 2005 constitution, and opening unprecedented avenues for women in education, employment, and leadership.

Yet, in this part of the world, it is the past rather than the present that shapes how current events are seen. It is the stereotype and the cliche rather than the reality that matters.

When CNN asked the RSF spokesperson on April 26 about their objective, he said the group was "seeking to capture" al-Burhan and bring him to justice for "many treasons acts against the Sudanese people".

Because RSF was fighting at the beginning of the war for the cause of the neoliberals - namely, to rid the country of the Islamists international think tanks, the likes of the International Crisis Group (ICG), have not hesitated to wish it well.

In a report released in July 2023, the ICG stated: "The RSF has held the upper hand in Khartoum since the early days of the war, but that

advantage is only growing more apparent. Even some army backers suggest the RSF is on the cusp of decisive military victory in the capital, especially if it can soon overrun the compound where army leader General Abdel Fattah al-Burhan and some of his key lieutenants are sheltering. The RSF has besieged the headquarters almost since the conflict began; it has now tightened its grip."

Calling the SAF's claim to the title of national army "dubious", the report went on to assert: "Given internal fissures and the deep hostility toward the RSF, any settlement raises the risk of a split in the army, including the possibility that hardliners team up with Bashir-era Islamists to fight on. An RSF victory would likely leave no place for those Islamists. who might then face a difficult choice among negotiating surrender terms, battling on in a losing cause or seeking safe passage to a third country."

The sidelining of Islamists in Sudan is clearly a top item on foreign agendas for Sudan.

Apart from failing to see the military progress made by SAF, courtesy of its air superiority, the ICG also did not register the change in RSF's goals for the war. While RSF needed the neoliberals for the purposes of winning international legitimacy, talk of "restoring civilian rule" figured prominently in its rhetoric.

But as the war scales tipped in favour of SAF, RSF was more in need of a source of fighters to join the war. The neoliberals were of little help in this regard.

As a result, the RSF spokespeople started to claim that their goal is to end "the 1956 state" controlled by riverine communities of central and northern Sudan and to replace it with one controlled by Junaid tribes, the ethnic groups of Arab origin that live in the Kordofan and Darfur regions of Sudan, as well as Chad and Niger.

The involvement of fighters from these tribes, be they Sudanese or non-Sudanese, is now a prominent feature of this war. Of course, this has momentous implications for the territorial integrity and sovereignty of Sudan and for the peace and security of the region. As Rosalind Marsden, the former

UK ambassador to Sudan and associate fellow at Chatham House, has warned: there is a risk of a "de facto partition, in which Hemedti controls Darfur and much of Khartoum, SAF controls much of the rest of the country, especially the east and the north, and an armed movement led by Abdel Aziz Al Hilu contests South Kordofan and southern Blue Nile. Indeed, in an audio recording released on September 14, Hemedti suggests for the first time that, if Burhan establishes a

government in Port Sudan, he will form a government in Khartoum".

Yet this dimension is not taken seriously enough by the international community. For the United States, for instance, the most urgent concerns in Sudan shifted from the exclusion of Islamists to addressing humanitarian needs, not putting the country's transition back on track. Being Sudan's largest contributor of humanitarian aid, the US has expressed its support for a ceasefire and peace negotiations to make delivering aid possible.

Indeed, providing humanitarian assistance to displaced Sudanese people should be the top priority, particularly in the Chadian border town of Adre, where many have fled from neighbouring Darfur. Nonetheless, if the transition is not fixed, the humanitarian crisis will persist for years to come.

Last week, it was announced that SAF and RSF have resumed talks in Jeddah with the hope of agreeing on a ceasefire, and possibly a deal to end the war. With SAF gaining the upper hand on the main battlefield and RSF losing military momentum, it is expected that the latter will sue for peace. This is particularly so because the meandering lines of tribal fighters from Western Sudan to Khartoum started to dwindle.

About two weeks ago, mediators from the African Union and the subregional Intergovernmental Authority for Development (IGAD) visited Cairo to consult with politicians on how to start an allinclusive process to restore the Sudan transition to its path. Perhaps there is a ray of hope after all.

The Sudanese people are hardwired for freedom. A call for elections will resonate with many. Sudan is not new to multiparty elections which were held even during al-Bashir's regime. In 2010, the polls that were convened at the end of the transition period following the second Sudanese civil war were monitored by the Carter Center and were seen as highly credible.

It is not true that the Sudan war is a fight between two generals. Nor is it a war that was "decades in the making", as the ICG report would have us believe. To be sure, this is a war that was triggered by a derailed political transition

The parties who caused that to happen still do not see the need for the country to pivot to the path of its transition. For them, a return to the transition implies the vanquishing of RSF and, even worse, the return of Islamists. If that is the likely outcome, for some, it is better to see the country disintegrate. Yet, many active players are now convinced that there is no viable alternative for this country other than to restore the transition to its path.

D'Insurrection' should bar Donald Trump from US presidency

Donald Trump should be disqualified from running for president again due to his role in the 2021 assault on the United States Capitol, lawyers have argued, citing an insurrection clause in the Constitution.

The former president, who currently enjoys a commanding lead in the race to be the Republican candidate for the 2024 presidential election, should be barred from running on the grounds that he "incited a violent mob" on January 6, 2021, it was claimed as a trial opened in a Colorado courtroom on Monday.

The Citizens for Responsibility and Ethics in Washington advocacy group has launched a lawsuit seeking to use a Civil War-era provision of the US Constitution barring anyone who has engaged in "insurrection or rebellion" from holding federal office.

The group hopes to block Trump from running in Colorado's ballot, and that the test case could then help bar his way to running in other states.



7 common signs of a troubled teen

ADOLESCENCE is a time of critical development, both emotionally and physically. At this time, teenagers begin to establish their own identities and seek more independence in their everyday lives. Their behaviors might involve distancing themselves from parents, acting out, or rebelling against the rules, in order to assert themselves as selfsufficient and in-control. While behaviors like these are typical for teenagers, there are red flags that can signal more troubled teenagers.

"Troubled" is a term that is often used for teenagers who are facing distress. This distress is frequently related to one's mental health, and causes negative behaviors like substance use, skipping school, and acts of violence. These problems go beyond the scope of typical teen behavior. If a troubled teenager is not helped, it can lead to issues in his or her adult life.

Because teenagers are inherently temperamental, it can be difficult for parents to determine when a teenager is struggling and when it is time to get help. If you believe your son or daughter is exhibiting signs of troubled teen behavior, it is important to contact a professional. If you are unsure if his/her behaviors are cause for concern, read on. Below we outline the common signs of a troubled teenager, versus signs of normal teen behavior. Almost all teenagers show signs of mood swings, defensiveness, and disobedience. You may find that your teenager is becoming more distant and prioritizing time with friends. He or she may be testing the waters with new looks to draw attention or to develop a sense of style. These are all normal behaviors that come in adolescence. However, there are some signs that can indicate a more troubled teen.

Warning signs of a troubled teen

Extreme Mood Swings: With adolescence comes changes in hormones and body chemistry. This can lead to occasional mood swings in teenagers. However, extreme mood swings - especially those that do not fit the situation can be cause for concern. If your teen is extremely happy, then severely depressed, for example, that would be classified an extreme mood swing. Or, if your child is exhibiting unreasonable fits of anger, disrespect, withdrawal, hostility, sadness, take note. A radical change in sleeping patterns, such as sleeping all the time to not sleeping at all, can signal troubles with your teen.

Sudden Change in Friend Groups: As noted, teenagers tend to spend more time with their friends and are more significantly influenced by their social circles.



At this age, it is common to make new friends as they develop their sense of self. However, if your teenager has completely abandoned old friends, like a best friend from third grade, and started hanging out with an entirely new group that you do not know, you may be concerned. This new friend circle may not come around to the house, and cause your teenager to act out more than usual. If your teen has a new questionable friend group, and in turn has changed their behaviors and attitudes for the worse, this is a common sign of trouble on the rise.

Sudden Changes in Behavior: Another sign of a troubled teenager is a marked change in one's normal behavior. As a parent, you know your son or daughter well. You know how long they sleep, how motivated they are, how anxious they are, how they perform in school, and what they enjoy doing in their free time. You know what makes your teenager comfortable and what sets them off. So, if you see a change that is markedly different from your teen's usual, it may raise a red flag. Examples of abnormal behaviors that teens might display include sleeping too long (or not enough), forgetting to do things, lying to and manipulating others, missing school, hating once-loved activities, disrespecting others, or distancing from friends and family. It may also involve increased signs of aggression, anxiety, and/or depression.

Sudden Drop in School Performance:

A major, and seemingly random, drop in school performance is another red flag that your teen might be struggling with something outside of academics. If your child is usually consistent in their grades, but performance suddenly tanks, ask yourself if there is a reason why. Did they just change schools? Does it seem like something is bothering

them, like depression or a bully at school? Are they attending their classes, or skipping out? Are they using drugs? If you do not have these answers, ask questions to your teen. You may find the answers signal a bigger issue with mental health. Additionally, it is important to note that some teens struggle with learning disorders. These vary in symptoms and severity, but can include trouble retaining information or learning in certain methods. Parents should note that a drop in academic performance could signal a learning disorder, as well, which would also require professional help.

Violence and Abuse: Teenagers facing mental health disorders will often have difficulty controlling their emotions. They may display unusual amounts of anger and aggression. Some teens may take that anger to a new level, by lashing out on others. This may include starting fights at school, teasing their peers, or acting violently towards those in the home (including people and pets). If your teenager is getting in trouble for violent acts, or threatening others and their belongings, this is a tell-tale sign of a more serious, troubling issue.

Self-harm: Teenagers who are troubled with mental health problems do not always pose a threat to others, sometimes they threaten to hurt themselves. If your teen is displaying signs of self-harm, suicidal thoughts, or dangerous behaviors that could be fatal, seek help immediately. This is a clear sign of mental health disorders in teens, and that something more troubling is taking place. Common signs include self-mutilation, dangerous drug abuse, and threats of suicide.

Substance Abuse:

It is not uncommon for teenagers

to drink or use drugs. This is an age where risk-taking and fitting in with friends is at its peak, and many teenagers will use drugs to make a statement in some way. However, substance abuse at this age is very dangerous—and frequent, recurring substance abuse among teenagers is cause for concern. Outside of peer pressure and the desire to try something new, many troubled teens will turn to drugs and alcohol as an escape. They may try drugs to make them feel better, whether that be to numb a pain or be more social in a situation, due to an underlying mental health disorder. This can start a cycle of addiction. As a parent, it is important to watch out for signs that your teenager is using drugs. These signs include increased secretive behavior, distancing from family and friends, lying to you about their whereabouts, lack of energy and motivation, and changes in their eating and sleeping patterns. Check out the top signs of drug abuse in teenagers, and know when it's time to seek help.

Signs of typical teen behavior: As noted above, teenage behavior can ebb and flow throughout development. Teenagers will be temperamental and moody at times. They will distance themselves from family occasionally, in efforts to fit in with their friends. However, it is important for parents to know the difference between the troubling signs above, with the more typical behaviors below. Here are some common teen behaviors that get confused with the above:

Mood Swings:

Teenagers can be irrational, impulsive, irritable, and disrespectful at times. They are growing and figuring life out. Some highs and lows are normal for teenagers to experience. However, jumping from extremes is where the concern begins. Friends First:

Teenagers are very social beings, and highly influenced by others. They rely on their friends' acceptance and perceptions to understand their place in the world. Research shows that teenagers prioritize social interactions and experiences more than any other point in life. As a result, most teenagers want to hang out with their friends more than their family members. It is the rapid changing of friend groups that can be a red flag.

Changing Appearance: As teens begin to develop their identities, they will start playing with fashion a bit more. They may choose styles that are more provocative or attentionseeking than their parents might prefer. However, this is a normal stage of development. Changing appearances can become a red flag if it goes beyond fashion, however. Signs of cutting (self-harm) and excessive weight loss or gain, for example, are more concerning changes that are worth attention.

Desire for Independence: Becoming a teenager means embarking on a new stage of development. It brings with it an increased desire for independence and sense-ofself. Teenagers have an inherent desire for freedom outside of their home and families. They will, often, do what they want to do (rather than what they are told). However, they still benefit from structure. Parents should continue to implement rules and boundaries during adolescence. Those who are increasingly defiant to those rules, without any regard for their parents or the consequences, may indicate a more troubling situation.

If you have found that your teen is in fact showing troubling signs, the next best step is to speak with a professional about your options. Many troubled teenagers act out or act negatively due to deeperseated issues with their mental health. For example, many teenagers display troubling behaviors as they fight against anxiety, depression, trauma, attention-deficit hyperactivity disorder, body dysmorphia, and substance addiction, to name a few. You may contact your family doctor or therapist for help.

Worm infection in babies and

WORMS, small and often unnoticed parasites, make their home in the child's intestines, where they leech nutrients from their host's diet. This type of infection, medically referred to as a Helminth infection, contributes to the prevalence of stomach aches in children. Given the frequency of these infections, it is crucial for parents and caregivers to acquaint themselves with the various types of worms in kids poop that can afflict children, as well as the multifaceted aspects related to the causes, symptoms, and treatment of worm infections

Being well-informed empowers individuals to take appropriate steps in preventing and managing these infections, ultimately safeguarding the health and wellbeing of their children. There are various types of worms that can breed in the human body. The most common worms that infect babies are:

Tapeworms, also called flatworms, have hooks and suckers that attach to the intestines and breed on the partially digested food. A tapeworm can be as long as a few inches or even 40 feet in length! Children generally ingest them through contaminated food. Roundworms: Roundworm infection is caused by the worm Ascaris lumbricoides. They are hollow in shape and can grow 35 cm in length. Roundworms inhabit saltwater, soil and fresh water, and are generally passed on to humans via pets.

Pinworms/Threadworms: Pinworms, also termed threadworms, are small, thin, and white worms that reside in the rectum. When the person sleeps, the female worm lays eggs in the anal area. This results in itching that transfers the eggs to the child's fingers. These eggs survive on clothes, bed linen and toilet seats, and get ingested through contaminated food and drink. Pinworm infections are most common among babies and toddlers. Hookworms: Hookworms usually occur due to



poor sanitation. These are small parasitic worms that attach themselves to the intestinal walls. A child can catch a hookworm infection on coming into contact with contaminated soil.

How will you know if your child has worms? Children seldom display symptoms of being infected. The infection could also be minimal and therefore, go unnoticed. We recommend that you get your baby checked if you spot any of these symptoms of childhood worms: Foul-smelling stools. Itching around the anus, abdominal pain, fatigue, diarrhoea, weight loss, vomiting

Loss of appetite, lack of sleep, jaundice, irritability, stomach trouble, bowel issues, restlessness and anxiety, gas and bloating, constipation. A few serious complications are obstruction of the small intestine, appendiceal lumen, bile duct, and pancreatic duct; intestinal volvulus; intussusception; peritonitis due to perforation of a viscus; and liver and lung abscess.

What Are the Causes of a Worm Infection? How do kids get worms? Babies and young children are likely to get infected with worms while crawling and playing outdoors. The most common causes that help the development of worms in babies are: Coming into contact with an infected surface. Consuming infected food or water, poor hygiene or lack of cleanliness, consumption of raw or undercooked food, improper washing of hands, contact with an infected person.

There are tests to determine a worm infection. Doctors can pinpoint a worm infection in children by the following tests: Stool Examination. A stool sample is sent to the lab to determine the presence of worms or worm eggs. Fingernails Examination

The doctor examines the baby's fingernails for worms or faeces underneath. Sticky tape test. This test is specifically performed to detect threadworms. A piece of tape is placed on the baby's bottom to collect worm eggs if any. Cotton Bud Swab.

A cotton bud is used to check the baby's bottom for the presence of worm eggs. Ultrasound Test, this test is only performed in cases of severe infection. Here, the doctor uses ultrasound to detect the exact location of the worms.



There are effects of Worms on a Baby's Growth. Worms are parasites that live in and derive nutrition from the body of their host. They impair children's health in the following ways:

Worms cause the loss of iron and protein and often lead to anaemia in children. Roundworms result in the malabsorption of nutrients. Worms cause a loss of appetite, a decline in nutritional intake and weakness. They are also responsible for diarrhoea and dysentery in babies and toddlers.

Wash your hands every time you change the diaper.

Keep the house and surroundings clean.

Ensure that your toddler wears closed shoes while playing and washes his hands and feet after returning home.

Don't let him play near waterlogged areas. Cut your baby's nails frequently.

Give your baby only boiled and filtered water Baby food should be cooked well to prevent a worm infection. Wash fruits and vegetables with clean water before cooking. Wash clothes and bed linen with hot water. Keep your baby's potty seat clean.

The FG, NLC impasse

For the umpteenth time, the Nigeria Labour Congress and its affiliate unions have threatened to go on another indefinite strike if its demands are not met by the Federal Government (FG).

Shortly after power batons exchanged hands on May 29, 2023, the announcement of the fuel subsidy removal by the President Bola Tinubu made Nigeria's economy to plunge, causing untold suffering for citizens. These provoked series of industrial actions and threats by the NLC and its affiliate union Trade Unions Congress (TUC).

Indeed life in the country has worsened. Daily increase in food prices, outrageous transport fares, hike in school fees, soaring prices of commodities, cooking gas costs, house rents, inflation and other economic crisis have become the order of the day.

As the economic crisis bites harder, the FG should urgently take concrete actions and implement the agreements it reached with Labour Leaders, to avert another planned nationwide strike.

NLC President, Joe Ajaero, and his TUC counterpart, Festus Osifo, unhappy with the harsh economic realities were still magnanimous to listen to reason and call off its planned strike for the best of the country.

Also concerned with the worrisome situation, apart from announcing a N5bn Naira relief package to states, Nigeria's President in an address on 1st October 2023 announced a short-term wage award of N35,000 to all federal government workers beginning from the month of September pending when the new national minimum wage is expected to be addressed.

Other agreements in the Memorandum Of Understanding (MOU) signed by Labour and the FG includes provision of high-capacity **Compressed Natural Gas (CNG) buses for mass** transit, implementation of various tax incentive measures for the private sector and general public, payment of N25,000 Naira per month for three months starting from October 2023 to 15 million households, including vulnerable pensioners and increase its initiatives on subsidized fertilizers to farmers across the country among other laudable solutions

The FG should therefore hasten up and implement its MOU with Labour to make life meaningful for Nigerians and to avert another strike. Government needs to revisit its economic policies, so that life would be better for the citizens.

FG and the Minister of Labour and Productivity who are handlers of the agreementimplementation should step up their game because another strike certainly is not the answer, it only grounds the system and heats up the polity adding salt to the injury.

State governments too should act fast and think of strategies to alleviate the suffering of their civil servants and citizens. Already Benue State Governor, Rev. Fr. Hyacinth Alia has set the pace with his purchase of 100 buses to be pumped into the state's transport system -'Benue Links' to ease the suffering of his citizens. Some other states too have taken strategies to reduce the suffering of their workers.

This is not time for the display of affluence and extravagance by the political class while citizens wallow in suffering. Therefore another solution to the problem that will convince abour to see the commitment of FG to the problem is for the FG to set the pace by cutting cost of governance so that it will be emulated at the state, and other levels.

Truth be told, the salary and take home pay of workers is not feasible. Therefore, reasonable solutions should be implemented as fast as possible. The Labour - FG issue should be addressed before it takes a different dimension.

If the economy does not improve, and economic solutions are not proffered, the situation can get out of hand and may become disastrous as spelt out in the adage "A hungry man is an angry man". Therefore, preventing a state of anomie, as a result of a harsh economy must not be allowed to happen in the country.





Unskilled animal husbandry, pastoralists' migration, others hamper milk production in Nigeria

Nigeria's per capita consumption of milk is eight litres, below the global average of 44 litres, according to the Food and Agriculture Organisation (FAO) thus leaving a deficit of 36 litres per capital write Abubakar Ahmadu Maishanu

It is late August and Illiyasu Atawame is milking his cows at his hut in Jigawar Tsada, a village on the outskirts of Dutse, the Jigawa State capital. The manual routine has been a key part of his practice in the last 40 years.

The Fulani pastoralist moved to the area from Jahun Local Government Area of the state in search of pasture for his livestock. Mr Atawame says life has become difficult for him and other pastoralists.

"It is no longer what it used to be because of shrinking grazing land.

"If you entered the bush with your animals, apart from the fresh grass, you would find groundnut and bean leaves left behind by farmers after harvest of their crops. But farmers nowadays go home with everything. They fight you over corn stalks in the dry season, how much more over their crops in the rainy season."

Herders like Mr Atawame move their cattle over long distances to seek grazing areas, which sometimes leads to violent clashes between the herders and local farmers whose farms the cattle destroy. The effects of climate change, such as desertification in the far north of Nigeria, have also limited the available grazing land.

Mr Atawame's average of two litres of milk per cow during the rainy season is just slightly higher than the national average by migrant pastoralists.

"The productivity of local cow breeds mostly managed by pastoralists is low at 0.5 to 1.5 litres of milk per day, compared to a global average of 6.6 litres per day by cows managed by pastoralists,' Dianabasi Akpainyang, the national president of the Commercial Dairy Ranchers Association of Nigeria (CODARAN), says.

Apart from the challenge of the breed of cattle many Nigerian herders use, which experts say is not the best for milk production, the pastoralists are also largely uneducated and get little or no support from the government.


Mr Atawame says he has never had any training on how to improve his practice. He has continued to rear and milk his cattle exactly the way he inherited the practice from his father. Told that he can increase his yield tremendously by using technology and embracing modern practice, he replies hopefully: "I am ready to learn if I have the opportunity."

Another pastoralist in the community, Abubakar Atiku, says he gets about five litres of milk daily from his cows. 

RARELY in modern times can so few have tried to take so much from so many. If Nigeria had lost its arbitration dispute with Process & Industrial Development in a London court on 23 October, it would have cost our people close to USD15 billion. We won, and all decent people can sleep easier as a result. Justice Robin Knowles said Nigeria had been the victim of a monstrous fraud. But it was a close-run thing.

As the judge said: "I end the case acutely conscious of how readily the outcome could have been different, and of the enormous resources ultimately required from Nigeria as the successful party to make good its challenge." But ordinary Nigerians never took the decisions that ended up before Justice Knowles.

Had Nigeria lost, it would have required schools not to be built, nurses not to be trained and Buhari roads not to repaired, on an epic scale, to pay a handful of contractors, lawyers and their allies – for a project that never broke ground. How did it get to this point? How did Nigeria prevail? Was this a one-off, or par for a shabby and distasteful course? What are the lessons for the future?

The 'P&ID Affair' was already firmly set by the time I came into office in 2015. A company registered in the British Virgin Islands that no one had heard of,

with hardly any staff or assets, had won a contract to build a gas processing plant in Cross Rivers. The company was owned by Irish intermediaries who knew Nigeria well and had done business in everything from healthcare to fixing tanks.



The problems facing Hag at Old Trafford

By SIMON STONE

AS he tiptoed round the thorny issue of why Manchester City are so much better than Manchester United, Pep Guardiola was careful to be both respectful and protective of fellow manager Erik ten Hag.

But in speaking about his own club, Guardiola still managed to indirectly shine a light on the current state of his city rivals.

"I said many times we are in the same direction - chairman, CEO, sport director, manager and players," he said.

"We make mistakes, of course, but when we lose or things are not going well we are not here to blame someone, we just see what we have to do to be better and find a

"In my first season, we didn't win. I didn't find my chairman complaining, he supported me unconditionally. When we lost the Champions League final against Chelsea I was devastated. My chairman said, 'Come on, we are going to win it, what can we do next? Let's go.'

"When that happens we are not overexcited when we win and when we lose we are not dramatic. That's why I think the club is so stable."

In black and white, it seems so simple. Yet at United, with uncertainty over the ownership, a public falling-out between manager questions over recruitment, being stable is a status that seems totally beyond them.

So, just as happened during the Mourinho and Ole Gunnar Solskjaer, significant progress made in one season under Erik ten Hag is in danger of being swept away by regression and mediocrity in the next.

Ralf Rangnick's appointment as interim manager when Solskjaer was sacked in November 2021 is something that Manchester United largely now widely regarded as a

Andre Onana cost £47.2m after Ten Hag took the bold decision to ditch David de Gea, believing the Cameroon international's superior ability with the ball at his feet would be a major positive.

And, while many feel England midfielder Declan Rice would have been a perfect fit at United, instead they ended up signing SofyanAmrabat, initially on loan, from Fiorentina.

Aside from injuries to Luke Shaw, Lisandro Martinez, Casemiro and Aaron Wan-Bissaka, there was one other player whose services were not under consideration by Ten Hag against City.

While Jadon Sancho has not vet done much to justify the £73m Solskjaer paid for him two years ago, the continuing stand-off between the England winger and Ten Hag does not reflect well on either side.

Sancho has been encouraged by team-mates to deliver the apology Ten Hag demands for his inflammatory social media post, which came in response to his manager's declaration he had been left out of the defeat at Arsenal on 3 September because of substandard training performances.

While BBC Sport has been told the Sancho situation is complicated, it was also pointed out such matters are better dealt with on the training field at the time.

But Sancho's words, which have now been deleted, were damning and complained of the 23-year-old being made a "scapegoat". Is it plausible he is the only player who feels this? And what does that say of Ten Hag and the way he has managed his squad?

Ten Hag arrived from Ajax almost 18 months ago, having forged the reputation of a modern-day coach committed to the pressing game.

He stated to Viaplay after

Sunday's 3-0 derby defeat to Guardiola's City that he cannot replicate that at Old Trafford because he doesn't have the players and instead he needs to be more direct.

Yet Match of the Day pundit Danny Murphy is not alone in thinking some of United's more established players simply do not work hard enough.

On top of this is United's ongoing search for "strategic alternatives", launched on 22 November last year with the aim of "enhancing the club's future growth, with the ultimate goal of positioning the club to capitalise on opportunities both on the pitch and commercially".

Following the withdrawal of Sheikh Jassim, who was adamant his bid to buy 100% of United was the best for the club, it now seems certain the other major bidder. Sir Jim Ratcliffe'sIneos Group, will get involved with an initial 25% stake.

He will enter a club whose overall debt, including outstanding transfer fees, now stands at over

It has been suggested Ratcliffe will have control of all sporting matters but, in a commercial enterprise the size of United, that in itself feels complicated. Even those close to Ratcliffe wonder how someone as controlling as the 71vear-old will work alongside the Glazer family, who have driven the commercial side of the club and not been scared to make decisions that benefit them no matter what outside criticism it draws.

Had Sir Bobby Charlton's death not taken precedence, it would be easy to imagine the prospect of the Glazer family remaining 'in charge' at Old Trafford drawing more supporter protests. Given the outcome of yesterday's game, it is inevitable the fan disquiet will resurface pretty soon.

Evidently, this whole situation is way off the serene picture painted by Guardiola of life on the blue half of the city. Positive results can mask inherent issues. But they also make it easier to deal with them, away from the glare created by defeats and below-par performances, which is where United and Ten Hag are right now.

Murray not enjoying tennis after a loss

ANDY Murray says he is "not enjoying" his tennis after suffering an agonising opening-round defeat by Australian Alex de Minaur at the Paris Masters.

BBC SPORT said that, the 36-year-old fell 7-6 (7-5) 4-6 7-5 to the world number 13, who he has never managed to beat in six meetings.

Murray twice served for the match and missed match point in another gruelling contest lasting just over three hours.

"I'm not really enjoying it just now in terms of how I feel on the court and how I'm playing,' Murray said.

'The last five, six months haven't been that enjoyable, so I need to try and find some of that enjoyment back because playing a match like that

Murray smashed his racquet twice during the match against De Minaur and the loss means the Scot has still not won a match at the Paris Masters since winning the tournament in 2016.

Despite his negativity, Murray did not give any indication that he could retire but said he would need to do "a lot of work" if he wants to keep playing.

"It's not just going to be like one or two weeks of training to get me to where I need to get to, it's going to have to be a lot of work and consistent work to give myself a chance," he added.

Murray, who has lost five of his last six matches, failed to convert three match points against De Minaur in Beijing last month and this latest loss in Paris is his fourth against the 24-year-old this year.

His opponent saved set points before pinching a close opening set with a narrow tie-break victory.

Murray recovered with a more second, breaking in the ninth

Murray's record against De Minaur this year also includes defeats at Monte Carlo and Queen's, but it looked like the former world number one might break that losing streak after finding himself a double break up in the deciding set.

He had match point at 5-4 but missed it with a long return and smashed his racquet on the floor in anger after handing De Minaur a break-point opportunity, which he took to level at 5-5.

Murray became increasingly exasperated as he knocked the drinks bottles and towel off his bench before failing to hold either of his next two service games and squandering opportunities to force a final set tie-break.

He again smashed his racquet on the floor as he sent a return into the net and De Minaur closed out the win.

champion Caster Semenya says her focus is now "more about winning battles against the authorities" than collecting medals.

BBC SPORT said that. Semenya, 32, was born with differences of sexual development (DSD) and cannot compete in any track events without taking testosterone-reducing drugs.

The South African wants to hold World Athletics to account for discrimination against athletes with nyperanarogenism.

"I fight for what is right for humanity and for inclusivity," she said.

Speaking to news agency Reuters, Semenya - also a three-time 800m world champion - added: "My last chance to win at the Olympics was in 2016 - Paris [host of the 2024 Games] is not my goal. It is more about winning my battles against the authorities.

"In running I have achieved everything I ever wanted. They have never stopped me from being the great athlete I unbeaten; I've done my part." In July, the European Court of Human Rights <u>ruled in</u> favour of Semenya in a case related to testosterone levels in female athletes.

The case at the ECHR was not against sporting bodies or DSD rules - but specifically against the government of Switzerland for not protecting Semenya's rights and dates back to a Swiss Supreme Court ruling three years ago.

The ECHR found the Swiss government did not protect semenya. being

discriminated against when its Supreme Court refused to overturn a decision by the Court of Arbitration for Sport (Cas), which upheld the World Athletics rules. The judgement could yet be appealed.

Hyperandrogenism is a medical condition characterised by higher than usual levels of testosterone, a hormone that increases muscle mass and strength.

Under regulations compete in track events between 400m and the mile if



they reduced their testosterone levels. In March, World Athletics

ruled that DSD athletes must now have hormonesuppressing treatment for six months before being eligible to compete in all events.

Semenya ran in the 5,000m at last year's World Championships in Oregon, but failed to qualify for the final.

She has argued that taking testosterone-reducing introduced in 2018, athletes her health and that the ruling medication could endanger with DSD were only allowed to denied her and other athletes with DSD the right to rely their natural abilities.

Because of the Semenya could not defend her 800m title at the Tokyo Olympics, which took place a year later than planned in 2021.

"It is no longer about me fighting to compete, it is about fighting for what is right," she told Reuters.

She added: "I fight for all women in the world. This young, upcoming generation cannot face the same scrutiny, the same judgement. They must be treated right."
